



**Waiver of Liability  
Relating: Coronavirus/COVID-19**

On March 9, Florida Governor Ron DeSantis declared a State of Emergency for the novel coronavirus, COVID-19, outbreak. On March 11, 2020, The World Health Organization declared the novel coronavirus, COVID-19, a pandemic. On March 13, 2020 President Donald Trump declared the novel coronavirus, COVID-19, a national health emergency. COVID-19 is highly contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people over the past several weeks.

Shalom Preschool Chabad has put precautions in place to reduce the spread of COVID-19; however, Shalom Preschool Chabad cannot guarantee that you or your family, including your child(ren), will not become exposed to or infected with COVID-19. Further, because of the number of individuals involved in Shalom Preschool Chabad and the fact that many infected individuals appear to be asymptomatic, attending this program could increase your and your child(ren)'s risk of contracting COVID-19.

By signing this waiver, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID19. I also acknowledge that by attending Shalom Preschool Chabad and the related programs such exposure or infection may result in personal injury, illness, disability, and/or death. I understand that the risk of becoming exposed to or infected by COVID-19 at Shalom Preschool Chabad may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Shalom Preschool Chabad employees, contractors, volunteers, members, and participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense of any kind that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at or participation in Shalom Preschool Chabad programs ("Claims").

On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless Chabad Lubavitch of Greater Fort Lauderdale Inc DBA Shalom Preschool Chabad, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Chabad Lubavitch of Greater Fort Lauderdale Inc DBA Shalom Preschool Chabad, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any program.

I also acknowledge that I have been furnished a copy of the Shalom Preschool's "Standards of Safety and COVID-19 Plan", and I agree to comply with the protocols in the plan.
